

FRIENDS OF CARRINGTON MOSS ANNUAL REPORT 1st August 2024 to 31st July 2025





This document provides a report of the achievements of the Friends of Carrington Moss between August 2024 and July 2025 and summarises the meetings, activities and events arranged, hosted and/or undertaken by the Friends of Carrington Moss Committee members. It also includes a financial report, completed by our Treasurer.

Key Achievements

During this Annual Report period, much of our time has been focused on the New Carrington allocation, the Carrington Relief Road and the numerous planning documents that have been issued. We have also responded to a number of consultations (including Trafford's Local Plan and Call for Sites) and have raised complaints to Trafford on behalf of FOCM followers.

We have continued to publish blogs and other updates in our regular newsletter (you will find them in the list of our previous blogs and newsletters on our website at this <u>link</u>).

The Save Greater Manchester's Green Belt Group was successful in securing a court hearing about one of its Grounds (Additions to Green Belt), this will take place in October 2025.

The Places for Everyone Policy relating to New Carrington (which is available on page 450 of the adopted Plan) requires that the allocation is developed in accordance with a detailed Masterplan that has been developed in consultation with the local community and other stakeholders. Policy criterion 1 confirms that "the consideration of opportunities to restore habitats, strengthen ecological networks, and manage the carbon and hydrological implications of development, having regard to the presence of peat on parts of the site" are central to the Masterplan. Whilst we were involved in a number of workshops relating to the development of that Masterplan during our previous annual report period, these did not reference any aspect of the Natural Infrastructure Strategy (which would include the mitigation and compensation for the harms and losses to our natural capital assets). Disappointingly, there have been no workshops since July 2024.

The New Carrington Policy includes a number of criteria aimed at protecting the natural environment, the landscape and the historic environment. We are carefully considering the proposals as they are developed to ensure those policy criteria are met.

Given the purpose of the Masterplan is to provide a clear framework for planning applications, and the aim is to create a sustainable community in the allocation area, this should have resulted in no planning applications being accepted on the former Green Belt land until the Masterplan is approved. Sadly, Trafford reneged on their own policy and have approved a planning application for a Battery Energy Storage System (planning application 115160), without the Masterplan being in place. This led us to raise a formal complaint in June 2025.

Whilst, we meet regularly with Trafford officers and continue to promote the importance of Carrington Moss as a site of huge environmental importance and a local heritage asset, we have had little success in ensuring community voices are heard as the planning system is biased towards developers rather than considering the needs of local communities.

We continue to engage with other local groups, such as the Parish Councils, Positive Partington, Altrincham and Bowden Civic Society and Peak and Northern Footpaths Society, along with specialist groups like the Campaign for the Protection of Rural England (CPRE) and Cheshire/Lancashire Wildlife Trusts, and national groups such as the Community Planning Alliance and the Transport Action Network (this latter via meetings known as Highways to Hell). We have had very little engagement with landowners and developers during this year, but we continue to arrange visits to the moss for several local schools (primary and secondary) and have also provided presentations on the school premises.

In addition, we have continued to:

- Host our monthly online public meetings
- Submit FOI requests to various public bodies via whatdotheyknow.com (you can view the requests and the responses on that website, in total the FOCM Committee have submitted almost 100 requests)



- Analyse various datasets and publish the outputs and other relevant information via our blogs (you can find a list of our previous blogs and our monthly newsletters on our website at this link)
- Submit objections to planning applications which will impact Carrington Moss and its users
- Publish formal responses to various national, regional and local consultations (you can see our responses on our website at this link)
- Create and publish videos via our YouTube channel (you can subscribe to be notified when new content is posted)
- Support other local, regional and national groups with their activities and actions
- Raise awareness of the impact of the plans for Carrington Moss, including communicating with local people who are not connected to the internet
- Raise funding to support our activities and the legal/professional advice we need (see our Treasurer's report below).

For information, our Chair is Vice Chair of the regional group, <u>Save Greater Manchester's Green Belt</u>, and is also Vice Chair of the <u>Community Planning Alliance</u>, which is a national umbrella organisation for over 700 groups (all campaigning against inappropriate development).

Treasurer's Report

We continue to build our funds to support the legal and expert advice required to challenge the plans to develop housing, employment space and 4 major roads on and across Carrington Moss and would like to express our heartfelt thanks for your ongoing support. It is very much appreciated.



We have also had several "in-kind" donations (also known as a gift in kind), which means that we do not have to fund things such as the fees for our online meetings, the web domain and travel/transport costs to various events and activities our committee attends on our behalf.

Your generosity in supporting our appeals has enabled us to cover the legal costs paid out and at the same time grow the Legal and Professional Fees Fund by a small amount. Our regular income through the 200 Club and Easy Fundraising remains very important to us. If you haven't already done so, please encourage your family and friends to join these initiatives.

Membership of the 200 Club has remained stable in the last 12 months at an average of 140 entries per month and an average prize pot of £130 shared amongst the 3 prize winners. We are especially grateful to those winners who choose to donate their winnings back into the Legal and Professional Fees Fund.
